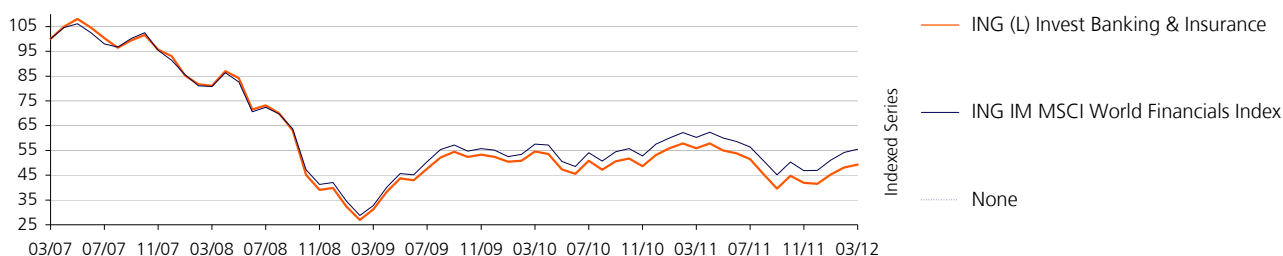

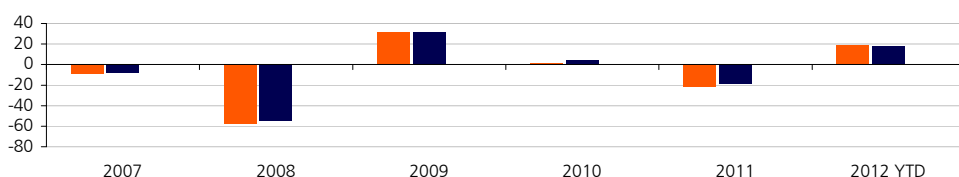

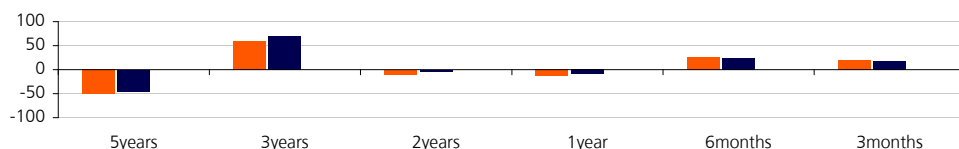


Calendar Year Performance (%)
