Per 29 April 2011 this fund absorbed Asian Debt, a sub-fund of the ING (L) Renta Fund SICAV. 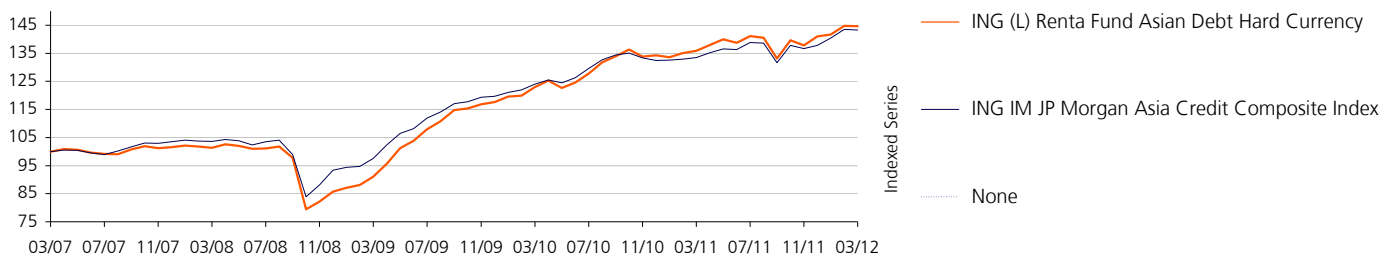

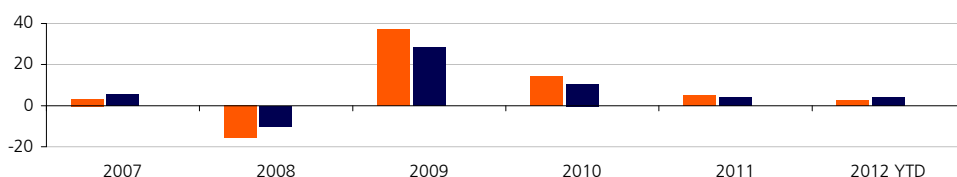

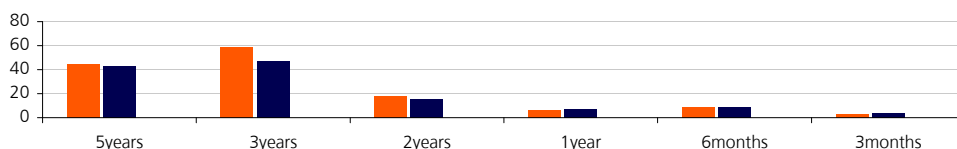


Calendar Year Performance (%)
